

**Encounter: Calais** 

In October 2016 the migrant camp in Calais, commonly known as 'the jungle' was bulldozed and the thousands of residents displaced, many of them taken to reception centres across France.

# The story didn't end there.

Since the demolition of the jungle many of those displaced have returned, and the wider political and social issues which contribute to the current migration situation have remained unresolved. There are hundreds of vulnerable migrants, many of them young people still in Calais, Dunkirk, and other parts of northern France facing hostile tactics from French riot police including teargassing and physical assault. The UK government contributes to the security situation in these areas. Calais is 26 miles off our coast.

Pope Francis has called on the Church to look to margins of our society. The young people in Calais, who don't fit any of our usual labels of "refugee" and face a daily struggle for survival could not be more marginalised.

Encounter: Calais is offering a chance for members of the church community in Scotland to engage with questions of welcome, to experience the situation in Calais, and participate in the work of some of the organisations on the ground.

## Is this for me?

This visit isn't an 'end in itself'. We are looking to engage with people who upon their return to Scotland can witness to their experience and engage others in supporting the work being done there. This could be in schools, parishes, chaplaincies, local communities, through ecumenical and interfaith networks wherever you are across the country.

So if you have a passion for social justice, a desire to explore Christ's command to 'welcome the stranger', and aren't afraid of a few days hard work: this could be for you!

## **Dates and Accommodation**

We have a small house in Calais where our group will be staying<sup>1</sup>. All participants will have their own room. We will live in a small intentional community with time for prayer and reflection on the experience. There will also be 1 meeting before and 1 meeting after for all participants.

There are three visits running to Calais in Jan/Feb 2019.

Group 1: Monday 28<sup>th</sup> January – Friday 1<sup>st</sup> February

Group 2: Friday 1<sup>st</sup> February – Tuesday 5<sup>th</sup> February

Group 3: Tuesday 5<sup>th</sup> February – Saturday 9<sup>th</sup> February

Groups will travel from Scotland early on their first day, have three days in Calais and return on the firth day.

# **Costs and Logistics**

Justice and Peace Scotland are asking for a contribution of £100 from each participant to the cost of this experience. If this amount is a significant barrier to you / your parish or school, please contact us.

All participants need the appropriate documentation to travel to France. (For most people this will be an UK or EU passport, but please check your own passport/ visas.)

All participants need the appropriate health insurance. For most people this is the European Health Insurance Card. ## **Drivers**

This visit is dependant on having drivers to travel to and from Calais with each group. If you are a driver and able /willing to assist in this way please let us know.

Drivers will be paid at the Bishop's Conference of Scotland rate of £0:45 per mile. (This is about £450 for a round trip Glasgow - Calais). Your vehicle does not need to travel around the Calais area, as Justice and Peace Scotland staff will facilitate transport in Calais.

Safe Passage advocates for safe, legal migration routes for vulnerable minors to in Europe. They involved with the #itsourturn campaign, calling on the government to take in 10,000 vulnerable children 80 years on from the *kindertransport* when the UK government offered sanctuary to 10,000 children in Nazi occupied parts of Europe.
